**G. Training Committee** Mike Blair

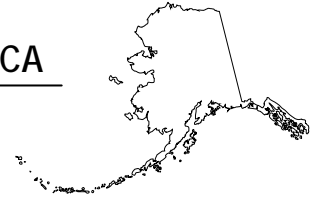
RALO training was held April 30-May 3 in Nome with Lanie Hughes and Mike Blair instructing under funding from AK Forum and another group.
