- IV. Board and General Membership Discussion
  - A. Committee Reports
    - 1. President's Report -Scott Barr
      - a. Scott thanked Public Works Director Terry Dolan for attending the meeting.
      - b. Scott deferred to Lanie Hughes in reference to the International Director position
        - 1. The question arises as to whether the Chapter should pay all travel costs for the International Director; in the past the Director's employer paid for WasteCon
        - 2. The two-year term was also questioned, as it takes time to learn the 'ropes'
      - c. The members voted to pay all expenses for any Director travel
      - d. The issue of term limits was tabled until the Nominating Committee makes its report

#### 2. Treasurer's Report - Butch Shapiro
